On December 6, 2017, Miami-Dade Water and Sewer Department (WASD) received your Demand for Stipulated Penalties letter dated December 6, 2016 stating that the Florida Department of Environmental Protection (FDEP) is assessing stipulated penalties pursuant to Section X, Paragraph 42(a) and the *Order Modifying Section X of the Consent Decree (Document 156)* in the amount of \$7,500 for eleven (11) Sanitary Sewer Overflow (SSO) events that did not reach the waters of the United States between January 1, 2016 and December 31, 2016.

In accordance with the provisions of the above referenced Consent Decree, on behalf of Miami-Dade County, the WASD submits Check No. 00660539, payable to "Florida Department of Environmental Protection" as payment for \$7,500 of the stipulated penalty as requested.


